Election Law Opinion DAD-57
Re: Selection of members of the State Executive
Committee

Dear Mr. Thorburn:

In your letter of August 18, 1982, you submitted the following questions regarding V.A.T.S. Election Code, art. 13.38:

- 1. Is election of the State Executive Committee empowered to the full convention or to the delegates from each senatorial district separately?
- 2. If the full convention must officially elect the entire State Executive Committee, does the phrase "to be those" limit their action to a ratification of a decision made by delegates in each senatorial district caucus?
- 3. Conversely, can the full convention disregard the vote of the senatorial district, as implied by the word "recommended," and select another person to serve on the committee?

This official election law opinion is rendered by me as chief election officer of the state in accordance with V.A.T.S. Election Code, art. 1.03, subd. 1.

Your questions may be summarized as follows: Are members of the State Executive Committee chosen by delegates from each senatorial district acting alone, or by the entire state convention?

Article 13.38, states, in pertinent part:

. . . The convention shall elect a chairman and a vice-chairman of the state executive committee, one of whom shall be a man and the other a woman, and sixty-two members thereof, two from each senatorial district of the state, one of whom shall be a man and the other a woman, the members of the committee to be those who shall be recommended by the delegates representing the counties composing the senatorial districts respectively. . . . (Emphasis added.)

Our construction of this statute would require that the members of the State Executive Committee be chosen by the delegates from each senatorial district, which choice may be ratified but may not be overturned by the convention delegates as a body. This conforms with what appears to the be legislative purpose of the statute.

In answer to your specific questions:

- Delegates to the state convention from each senatorial district have the right and duty to select the persons from their districts who will represent them on the State Executive Committee.
- 2. Any "election" of these State Executive Committee members would in effect be a ratification of the selections of the senatorial district delegates.
- 3. The state convention may not disregard the vote of the senatorial district delegates.

SUMMARY

Under the provisions of V.A.T.S. Election Code, art. 13.38, delegates to the state convention from each senatorial
